This update contains changes on pages 1 and 2 of the price list for all Nucor Steel Marion Rib Bak® U-Channel Post, SP 80 Delineator and Bend Bak® Delineator Products as well as for the Accessories Squared products found on pages 6 to 28.

Across the board price increases are noted on all Nucor posts and delineators averaging 9.4% on green posts and 12.3% on galvanized posts versus the August 2010 update. However, with the exception of galvanized posts over 18.5 feet in length, pricing remains below the originally awarded contract prices. The posts noted in the exception currently average between 3.5 to 7% above the originally awarded price. This is in response to a number of increases in raw material costs imposed by the steel industry since the first of the year.

These increases along with fluctuations in the hardware market influenced the changes shown by Accessories Squared. Prices here fluctuated with reductions of 2 to 3% in conventional hardware while steel based items showed changes in the 5 to 7% average range.

Accessories Squared introduced to their product line a Manual Post Driver and a Kleen Break Shear Bolt Wrench as low cost alternatives to their featured gas-powered drivers. Additional expansion anchors, galvanized pole caps and cantilevered brackets have been added to supplement existing products. The Triangular Multi-Directional Slip Base Component Sub Assemblies, and the BX 250G Kleen Break Model 425 Sign Post Coupler and their component parts were discontinued, replaced and updated with versions of the same product line that are more efficient and easier to install, and lower in price than their predecessors.

All other terms and conditions of the original award remain unchanged.

In comparison with the previous price list, this update only contains changes on pages 1 and 2 of the price list, for all Nucor Steel Marion Rib Bak® U-Channel Post, SP 80 Delineator and Bend Bak® Delineator Products.

The update announces the discontinuation by Nucor Marion of Green Powdercoated Rib Bak® U-Channel Posts of all weights in excess of 16 feet in length. Inventory of these items has been exhausted.

Near across the board price increases are noted ranging from 14 to 18.5% over the January 2009 update, with the exception of Green Powdercoated Rib Bak® U-Channel Posts of all weights and Delineators in lengths of 12.5 to 15 feet, and Galvanized Rib Bak® U-Channel Posts of all weights in lengths of 16.5 to 18 feet, where due to changes in the handling and manufacture of these lengths netted changes ranging from an 8% price reduction to a 9% price increase over the 2009 update. These changes are commensurate with steel pricing changes indexed and reported by the American Metals Market, which shows an increase in Steel Sheet prices over this time period from 17.3 to 21.4%.

Users should also note that the updated prices for all Rib Bak® U-Channel Posts in lengths below 18 feet, Galvanized 2 ½ pound posts over 18 feet and all SP80 Delineators are 2 to 11% below the originally awarded prices. Galvanized Rib Bak® U-Channel Posts above 18 foot lengths in 2, 3 and 4 pound and Bend Back Delineators are now 1.4 to 6 % above the original award. Comparatively the American Metals Market Index from the original bid date to this update reflects increases from 5.1 to 8.9 %.

In terms of changes from the previous catalog, there were across the board price increases to the all product categories ranging from 5.0 to 27.5% on Nucor Steel Marion Products. The bulk of the Nucor product showed increases of 13 to 27.5%, however as the 2.5# posts were a high production mover nationwide, the manufacturer was able to hold the increases to 5 to 7% for all Green Lengths and up to 16' on the galvanized product at this time. Allied Telspar items increased between 20.1 and 64.8%.

These increases correspond to economic conditions that have been taken place in the steel industry in recent years. Since the opening of the bid in April of 2007 for this award, the American Metals Market shows an increase in Hot Dipped Galvanized Steel prices from \$39 to \$65.15, up 67%, while Hot Rolled Steel increased from \$29 to \$54, an 86% hike. Corresponding to this the US Dept. of Labor, Bureau of labor statistics shows the Producer Price Index on Hot Rolled Steel Products in the same period increased 64.7% from 142.8 to 235.2, while the Steel Benchmark Service has US Prices east of the Mississippi, for the period beginning July 26, 2007 to today, for Standard Plate went from \$855 per metric ton, to a current rate of \$1586 up over 85%,
