The area milled and disposed of will not be included in the measurement and payment of item 416.1x cold recycling for any project, unless otherwise specified within the Special Notes affecting projects 9V1923, 9V1940, 9V1942 and 9V1973, found within Attachment 9 – Special Notes – NYSDOT Specific Projects (revised February 8, 2019).

All other terms and conditions of the Solicitation remain unchanged. All Bids shall be considered on the basis of any amendments. It is the Bidders’ responsibility to submit the most current versions of all Invitation for Bids documents.

If submitting a bid, this Bid Solicitation Update should be signed, attached to, and made a part of your bid. If submitting a superseding Attachment 1 – Pricing (revised February 8, 2019) to replace the one that was previously submitted, Bidders should include a cover page clearly stating that their new submission supersedes their original Attachment 1 that was previously submitted on such a date.
